CORPORATE HYBRID RECHARGE OFFER

Hybrid Prepaid Solution is a service which allows MOKAULENGWE INVESTMENTS to purchase airtime in bulk from Mascom and will be loaded once on a monthly basis. MOKAULENGWE INVESTMENTS will be required to provide a list of members together with their cellular phone numbers before the first day of every month. The list should be accompanied by a cheque which tallies with the total amount to be credited to members. In order to allow staff to benefit from the full recharge amount, the company can opt to pay VAT.

To qualify for a hybrid account the following conditions should be met

- Monthly Recharge per line must be P100 and above
- Total recharge amount should be P1000 and above
- Number of lines in the account should be a minimum of 10 lines.
